### **Questions 1 - 50**

1. Dr. Handy has just visited with the new resident at Happy Acres. He is in a hurry so he will delegate the task of writing the dietary orders to:
  - a. The Administrator
  - b. The Qualified Dietician
  - c. The Director of Nursing
  - d. The Dietary Supervisor
  
2. Mr. Highland's daughter is upset and feels that the staff at the Lazy Acres nursing home is neglecting her dad. If she wants to make a complaint regarding his treatment, what department would she contact?
  - a. Local Police Department.
  - b. Centers for Medicare & Medicaid Services (CMS).
  - c. Texas Department of Aging and Disabilities (DADS).
  - d. Texas Department of Human Services (DHS).

3. Stan Bac's wheelchair is equipped with a "self-release seat belt". Stan has progressive dementia and becomes confused at times. He can no longer demonstrate how to fasten and release his seat belt. What must the facility do?
- a. Have rehab assess Stan for a few rehab sessions to reinforce the technique for fastening and releasing the "self-release seat belt".
  - b. Call Stan's wife and have her come to talk to Stan about the importance of demonstrating how to fasten and release his seat belt.
  - c. Have Stan's wife come down and pick up the wheelchair. Since the seatbelt must be removed it is now too dangerous for Stan to self-propel around the facility.
  - d. Remove the "self-release seat belt" from Stan's wheelchair because it has now become a restraint.

### Answers 1 - 50

1. Answer is: B - The Qualified Dietician

**26 Tex. Admin. Code § 554.1205 - Physician Delegation of Tasks**

(d) A physician may delegate the task of writing dietary orders to a qualified dietitian who:

- (1) is acting within the scope of practice; and
- (2) is under the supervision of the physician.

2. Answer is: D - Texas Department of Human Services (DHS)

**26 Tex. Admin. Code § 554.604 - Complaint Investigation**

(a) A complaint is any allegation received by the Texas Department of Human Services (DHS) other than an incident reported by facility staff. These allegations include, but are not limited to, abuse, neglect, exploitation, or violation of state or federal standards.

3. Answer is: D - Remove the "self-release seat belt" from Stan's wheelchair because it has now become a restraint.

**26 Tex. Admin. Code § 554.424 - Wheelchair Self-Release Seat Belts**

(d) A facility is not required to continue to allow a resident to use a self-release seat belt in accordance with subsection (b) of this section if:

- (1) the resident cannot consistently demonstrate the ability to fasten and release the seat belt without assistance;
- (2) the use of the self-release seat belt does not comply with the resident's comprehensive care plan; or
- (3) the resident or the resident's legal guardian revokes in writing the authorization for the resident to use the self-release seat belt.
